Soil Building Systems Credit Terms

- Your statement will be mailed (or emailed) the first day of the month for all purchases made during the previous month.
- Full payment received by the 15th day of the month following the sale (Net 15th) will be considered "Timely Payment" or "Due Date". Payments received after the 15th of the month will be considered "Past Due." If not fully paid by the Due Date, interest will accrue on all past due amounts at the rate at 1.5% per month and will continue to accrue until the original invoiced amounts are paid in full, plus any interest charges that have resulted.
- SBS offers an "On-Time Payment Program" to reward those companies that consistently make on-time monthly payments. Customers that do not qualify for the On-Time Payment Program pay an additional 7% for materials and services. Payments received after the 15th will disqualify you for the On-Time Payment Program until the next timely payment is received (i.e., if you make timely payments, you will automatically receive the discounted On-Time Payment Program pricing).
- At the discretion of SBS, accounts with a delinquent balance may be put on a cash-payment basis or placed on hold.
- If payment has not been received within 40 days after the month of the sale, we are required by Texas law to notify property owners, general contractors, bonding companies, etc., in order to protect our collection rights. You are responsible for all reasonable collection costs and attorney fees necessary for collection of Past Due balances.
- A \$25 fee will be charged for all returned checks.
